# 2. Previous Minutes & Matters Arising from the meeting held 20 June 2024

Previous minutes were approved with the following comments:

# 3. Public Speaking:

#### 4. Health Update

AS gave a presentation: Public Mental Health Update.

 Following the Annual Public Health Report in 2021, Suffolk County Council has been working with Suffolk Mind to identify areas needing support. Haverhill was identified as one such area.



- Data was collected and analysed. Only 37% of Haverhill respondents felt that their needs were met (physical and emotional).
- Only 1 in 2 Haverhill respondents did not feel they enough control over their lives.
- On average, sleep is the worst met need. This could be due to social factors such as worries about housing, finances, work, etc.
- Training and workshops were set up in local areas to support community leaders on understanding public mental health and also to discuss potential project ideas.
- Funded projects in Haverhill:
  - Men's sheds.
  - Cradle to Career (in partnership with OHP).
  - HTC Arts Centre, various events in the arts, film and dance.
  - Walk, Talk and Bee Happy project.
  - Haverhill Youth Wellbeing Hub.
  - REACH Haverhill Wellbeing Passport.
- Most projects are coming to an end and are seeking funding. However, Cradle to Career has just started.
- Data collected has shown improvements in wellbeing. Soft intelligence from projects have been used to drive actions forwards as part of the Public Mental Health strategy.
- Focus due to demand is usually on crisis situations and treatment, but it is important
  that funding is spent on prevention to maintain good mental health and solutions to
  the causes of causes. As a system this requires a shift in the repurposing of funds
  to focus on the wider determinants of health. Conversations have begun on this but
  it is a long way to go, members are encouraged to highlight the important of
  prevention in the multiple forums and meetings which they attend.
- Further information on the strategy on Public Mental Health and Suffolk's response
  to the National Suicide prevention strategy was given, this is due to be signed off by
  the Mental Health Collaborative in October. Information will then be shared with
  Board members if of interest.

There was a robust discussion following AS's informative and interesting presentation, which provoked several questions. It was agreed that in order to highlight the good work and the sustainability of outcomes, there should be more public awareness. AR will liaise with AS and SH to formulate copy for publicity.

# 5. Knife Angel

#### 6. Promoting Haverhill as a Place to do Business

How to promote Haverhill as a place to do business was discussed in depth. It was felt that Haverhill has a lack of identity but there is so much to promote: global businesses



(Nyobolt, Bernhard and Company, TAIT) based in the town, great community spirit, lots of green space areas, the Arts Centre. In order to promote Haverhill, the following ideas were given:

- a) Boards on industrial estates need to be current.
- b) Industrial sites need tidying up. AT is trying to make progress on this.
- c) Promoting the businesses that are in Haverhill (especially the global ones). However, there is no Chamber of Commerce or business directory, which makes this difficult.
- d) Locally to Globally. AT is in conversation with West Suffolk Council to try to form a strategy.
- e) A 'Made in Haverhill' exhibition.
- f) KD informed the meeting about the Kickstart scheme funded by the Flexible Support Fund. DWP will fund scooter rental for one month so that individuals on benefits can get to work.

# 7. Game Anglia

Chris Filip from Games Anglia joined the meeting via Zoom and gave a presentation about the work this not-for-profit organisation does. The organisation is mostly volunteer run, and it aims to make East Anglia a better place. Games Anglia has been working with MENTA and for seven years has held events throughout Suffolk. Elevate Haverhill is a programme for young people over the age of eighteen at risk of committing ASB, to tell their story through the medium of creating a video game. The programme has space for up to thirty people and workshops will be held at the EpiCentre. Applications are currently open for week commencing, Monday, 28<sup>th</sup> October 2024.

Mr Filip will forward information to CP who will distribute to Board members so that they can promote this worthwhile programme with their fields.

#### 8. Reports from Task Groups

a) Crime & ASM (Drug & Alcohol Subgroup)

The meeting was deferred until 22<sup>nd</sup> October so there is nothing to report at this time.

# b) Integrated Care Board

Builders are on site at the Health Centre. It is expected that teams will be moved in by 1<sup>st</sup> December. The priority for communication this year has been on partnerships but next year the focus will change to communicating to the public.

Stourview – hoping for a wellbeing hub to be incorporated.

Collective GP action is planned but this should not affect patient care.

# c) Education, Skills and Enterprise

CP has received an email from Kirsty Pitwood, West Suffolk Council Economic Development, who is carrying out a skills needs analysis. A questionnaire for employers was attached. CP will forward it to Board members so that it can be circulated as widely as possible.

The possibility of setting up a built environment campus in Haverhill is being investigated with West Suffolk College. West Suffolk Council has proposed a site much larger than the one initially identified as a possibility, which is being explored. Already, interest around training has been received from some local companies, however, funding still needs to be found.

### d) Cradle to Career

Discussions have taken place to merge the 'Hands around Haverhill' intergenerational project which had previously received Public Health monies (£8,200) into the 'Serving the Community' strand of Cradle to Career project which is being led by Unity School Trust. JE, HE and AS to attend a network meeting at Castle Manor Academy on 27 November to meet Primary School contacts from the Unity Schools within Haverhill. The meeting is designed to ensure every school develops a deep understanding of the community it serves - working in partnership to strengthen capacity.

#### 9. **Any Other Business**

JE – Thriving Communities Fund: the closing date for applications is 12 noon, Friday, 27<sup>th</sup> September.

SH – Health Equity Fund: £55k has been allocated to Haverhill. £20k has been allocated to the wellbeing hub and the rest is to be spent locally. An agenda item for the next
